

DISTRICT PROGRAMS

Employment Workshop - weekly program assists unemployed and employed offenders.

Financial Management - two class course Assisting offenders with money management, budgeting, etc.

GED - classes held twice weekly to assist offenders in obtaining their GED.

Impact of Crime on Victims - 20 hour program that provides information on how many types of crime impact the victim, family and the community.

Pathway to Change - an evidenced based cognitive skills program designed to help the offender understand their thoughts, decision-making habits and alter their behaviors.

Sex Offender Therapy - Therapeutic program provided for offenders supervised for offenses requiring treatment.

Substance Abuse Education - educational weekly program dealing with all aspects of addiction and relapse.

Community Supervision Center

A residential facility that offers Probation and Parole Officers, Courts and Parole Board an alternative to sending violators to prison or an Institutional Treatment Center or other 120 day shock incarceration. Residents stay for up to 90 days, on house arrest leaving only to work or attend authorized appointments. Substance abuse and GED classes are required of all residents that are in need of such. Other programs such as victims groups and anger management are conducted in-house.

MISSION STATEMENT

The Missouri Board of Probation and Parole, as an essential part of the criminal justice system, is to provide for the professional assessment and release of offenders and their supervision in the community, using appropriate treatment, sanctions, and controls, with the primary consideration being the promotion of public safety.

INTERVENTION FEE

Under Missouri law, all persons under supervision are required to pay a monthly fee of \$30.00, due the 1st of each month. Payments must be made by money order and mailed in the envelope provided by your supervising officer.
