## **INTAKE**

ORIENTATION PROGRAM FOR FIRST TIME OFFENDERS. THE CONDITIONS OF SUPERVISION ARE REVIEWED, ALONG WITH INFORMATION ON HOW TO SUCCESSFULLY COMPLETE PROBATION/PAROLE.

## **DRUG COURT**

INTENSIVE APPROACH TO DEALING WITH OFFENDERS WITH SUBSTANCE ABUSE PROBLEMS. THE OFFENDER WORKS WITH A TEAM OF SPECIALISTS WHILE LEARNING TO MAKE POSITIVE DECISIONS WHILE ON SUPERVISION.

## **SEX OFFENDER THERAPY**

THERAPEUTIC PROGRAM PROVIDED FOR OFFENDERS SUPERVISED FOR OFFENSES REQUIRING TREATMENT.
