## DISTRICT PROGRAMS

### ***Day Report Program***

Clients are at the office all day for programming to assist with overcoming barriers to employment. Components include; High School equivalency classes, life skills training, cognitive behavioral classes, substance abuse education and employment assistance.

### ***Intake Program***

A series of group sessions provided to new clients and their significant others during the initial assessment phase to help them understand probation and parole supervision and prepare them to achieve a successful outcome.

### ***GED Program***

An on site class where a certified teacher provides testing, teaching and assistance to clients in acquiring a High School Equivalency Diploma.

### ***Substance Abuse Education Classes***

A 12 week cognitive structured substance abuse education program. Program runs every Wednesday 5:30 p.m. To 7:00 p.m.

### ***Victim Impact***

A 12 week program exploring the impact of crime on victims.

### ***Vocational Rehabilitation***

Special program designed to help individuals with physical and or mental impairments obtain employment. Screenings once per month.

### ***Pathways to Change***

A 12 week cognitive restructuring program geared to help clients re-evaluate their decision making process so they can make better choices.
