Free and Clean: Intensive out-patient substance abuse treatment for offenders who have completed 120 day institutional treatment or long term institutional treatment

Domestic Violence Unit: Intensive supervision of Domestic Violence Offenders including batterer's intervention services and close monitoring of victim contact (St. Louis City Probationers only)

MERS/SHIRMER HOUSE: Residential facility for female probationers and parolees, including case manager services
